

## ACCIONA SPONSORSHIP / SMALL GRANTS APPLICATION



ACCIONA's energy division is a world leader in renewable energy. In Australia, ACCIONA owns and operates the 192MW Waubra Wind Farm and the 132MW Mt Gellibrand Wind Farm in Victoria, the 46.5MW Gunning Wind Farm in New South Wales and jointly owns the 66MW Cathedral Rocks Wind Farm in South Australia with Energy Australia. ACCIONA is currently constructing their fifth wind farm, which is the 157.5 MW Mortlake South Wind Farm in Victoria.

In the area of solar generation, ACCIONA constructed the 20MW Royalla Solar Farm in the ACT for FRV. ACCIONA generally offers sponsorship / small grants for the communities in which we have wind farm project interests.

### SELECTION CRITERIA

ACCIONA invites sponsorship / small grants applications from community groups who wish to contribute to the sustainable development of the communities in which we operate. Applications for funding must be 100% in line with the ACCIONA social action plan, thus they must meet one or more of the following criteria:

- Enhance education, healthcare or cultural development
- Promote sustainability, the environment & conservation
- Promote, provide or support the provision of basic energy & water services
- Actively contribute to driving and improving the socio-economic system of the communities where ACCIONA operates

Sponsorship / small grants recipients must also satisfy the following:

- Operate as a not for profit
- Will have a direct link with the communities in which we have wind farm interests

ACCIONA will not fund third party fund raising activities, events that are illegal in nature, payment of existing debts, or activities and events whereby a solitary individual derives benefit.

## TERMS AND CONDITIONS

The following terms and conditions apply to all ACCIONA sponsorship / small grants applications:

- ACCIONA reserves the right to select:
  - successful sponsorship / small grants applicants;
  - the amount of the sponsorship / small grants allocation;
  - the method of payment; and
  - the timing of payment to successful sponsorship / small grants applicants

in its sole and absolute discretion.

- The decision to allocate sponsorship / small grants to successful applicants is final and ACCIONA is not required to provide reasons to unsuccessful sponsorship / small grants applicants.
- The sponsorship / small grants allocation must only be used and applied solely for the purpose of the project stated in the application. ACCIONA reserves the right to withdraw the sponsorship / small grants allocation if the money is not used for the purpose outlined in the application.
- ACCIONA must be advised if the project is no longer proceeding or cannot be completed within the agreed time frames.
- Expenditure of the sponsorship / small grants allocation must be completed within 6 months of receiving payment, unless otherwise agreed with ACCIONA.
- An acquittal form must be submitted to ACCIONA within 60 days after completion of the project. Failure to supply the acquittal form will disqualify the organisation from receiving future funding from ACCIONA.
- Any unspent sponsorship / small grants allocation must be returned to ACCIONA.

- Should the actual total project cost exceed the sponsorship / small grants allocation, ACCIONA will not be responsible or obliged to pay any monies in addition to the sponsorship / small grants allocation.
- Successful sponsorship / small grants applicants must maintain the appropriate insurances (including public liability insurance) and will provide ACCIONA with certificates of currency when requested.
- Successful sponsorship / small grants applicants will acknowledge ACCIONA in their media and advertising materials for the project. This information must be approved by ACCIONA before distribution.
- ACCIONA reserves the right to include details of sponsorship / small grants in its media, newsletters and website materials.
- ACCIONA reserves the right to withdraw the sponsorship / small grants allocation if an organisation has been found to be involved with illegal activities.
- ACCIONA will not accept incomplete, unsigned sponsorship / small grants applications (acknowledging terms and conditions) or applications submitted after the closing date.
- If a successful sponsorship / small grants applicant is registered for GST, the amount of the sponsorship / small grants allocation will include GST, subject to a valid tax invoice being supplied to ACCIONA.
